

Rules and Regulations of
ATME College of Engineering Alumni Association

ARTICLE I

Name

The official name of this organization shall be called, "ATME College of Engineering Alumni Association".

Address of the

ARTICLE II

Purpose

The purposes of the ATME College of Engineering Alumni Association are:

- a. To promote the advancement of the College by enlisting the support and participation of all of the College's Alumni,
- b. To promote the advancement of the College by keeping the College aware of current and future community and industry needs,
- c. To bring alumni together and all times maintain an avenue by which the Alumni may remain in contact with the College,
- d. To communicate information concerning the College, including activities and achievements to alumni,
- e. To promote and support fund raising that is consistent with the mission of the College,
- f. To offer opportunities for alumni to network with each other, students and the ATME College community.
- g. To improve the facilities and infrastructure of the college with the help of active participation of the alumni.
- h. To provide a platform for interaction between alumni, present students, faculty of the college and college administration.
- i. To make available the expertise and experience of the alumni for the development of research and educational activities of the college.

ARTICLE III

Membership

Section 1: Membership of the Alumni Association

- a. All graduates and former students of ATME college of Engineering shall be considered members of the Alumni Association.
- b. The Alumni has to become a member in the ATME Alumni Association by paying Rs. 300/- as a alumni membership fee.
- c. Honorary members of the ATME College Alumni Association will be considered and approved by the Alumni Council.

ARTICLE IV
Officers of the Association Council

Section 1: Council Officers

There shall be, in order of succession, a President, a Vice-President, a Secretary, a Joint Secretary, a Treasurer and Executive members.

Section 2: Duties of Officers

- a. President: The President shall preside at all Alumni Council meetings. The President shall appoint all committee chairpersons or direct a method for their selection. The President shall perform such duties as the by-laws may require, including the following duties: creation of the agenda for each Alumni Association and Alumni Council meeting, provision of leadership in the recruitment of alumni participation, and representation of the Alumni Association.
- b. Vice President: The Vice President shall perform the duties of the President in the absence, temporary inability, or resignation of the President, and other such duties the President may from time to time designate. He/She shall supervise and coordinate the work of all standing committees as needed, and shall recommend to the President individuals for selection as chairpersons and committee representatives for all standing committees.
- c. Treasurer: The treasurer shall work with the Office of Institutional Advancement to report on the financial status of the Alumni Association accounts maintained by the College. All ATME College Alumni Association financial accounts will be held at the College.
- d. Secretary: The secretary shall be responsible for recording the minutes of the proceedings of the Alumni Association and of the Alumni Council meetings. He/She shall submit a draft of the minutes of all Alumni Council meetings to the Coordinator of Institutional Advancement for distribution to the Alumni Council. Furthermore, all Alumni Council and Alumni Association meeting minutes shall be posted on the ATME College website for all members to peruse.
- e. Joint Secretary: The Joint Secretary shall perform the duties of the Secretary in the absence, temporary inability, or resignation of the President, and other such duties the Secretary may from time to time designate.

Section 3: Nominations and Terms of Office

- a. Officers shall be nominated by a member of the Alumni Council during the August Alumni Council meeting. The Alumni Council members will proceed to vote during that said meeting. Anyone nominated for Council Office must be present to be considered for nomination.
- b. The installation of the new Council Officers shall take place at the Alumni Association Annual Meeting. The officers of the Alumni Council shall serve two-year terms beginning April 1st.
- c. No officer shall serve more than two (2) consecutive two (2) year term in the same office, but shall not be barred from election to a different office. No person shall hold more than one (1) office at a time. This limitation shall not be applied retroactively, but shall only apply to terms begun after the adoption of this Section.
- d. The Council will determine the staggering of the terms of office and get feedback from the Council members at next meeting.
- e. Any vacancy that may arise in the council officers may be filled in by the remaining members.
- f. The council in its meetings shall consider the entire question effecting business that may be of interest to the members of the Association and they shall inform and circulate any information, which may be of use to the members.
- g. The working hours of the Association will be from:
Morning: 9 A.M. To Evening: 4.30P.M.

Section 4: Replacement of Officers

In the event of the resignation, dismissal, or death of any officer, it shall be filled by a majority vote of the Alumni Council. Any replacement officer so appointed shall serve out the remaining term of office.

ARTICLE V Meetings

Section 1: Regular Meetings

- a. The meeting of the Alumni Council shall be convened at the call of the President.
- b. The Alumni Council shall be convened quarterly at the call of the President. Additional meetings shall be called at the discretion of the President, the Office of Institutional Advancement or by a majority of the Alumni Council.
- c. When possible, agendas for all meetings shall be forwarded by the Office of Institutional Advancement not less than three (3) days prior to the meeting date. Such notices shall include the date, time and place of the meeting and the full meeting agenda.
- d. Quorum for each meeting will consist of the majority of the Alumni Council.

Section 2: Order of Business

- a. Agenda will be set by the Office of Institutional Advancement with review by the President and shall include but not be limited to:
 1. Call to Order
 2. Review and approval of previous meeting minutes
 3. Treasurer's Report
 4. Staff Updates
 5. Committee Updates
 6. New Business
 7. Adjournment

Section 3: Voting

- a. All motions that are to be voted on during an Alumni Council meeting must be submitted to the Council President or the Office of Institutional Advancement no later than one week prior to the meeting to be placed on the Council meeting agenda.

ARTICLE VI Committees

Section 1: Appointments

- a. All Committee chairpersons shall be appointed by the President. The President, Vice President and select members of the Office of Institutional Advancement will select a slate of nominations. The President will then make a recommendation to the Alumni Council to vote on.
- b. Committee members shall then be selected by the respective chairpersons. It shall be understood that Committee Chairpersons and members may serve for periods longer than two (2) years, at the discretion of the incoming President.

Section 2: Standing Committees

The standing committees shall be:

- Public Relations and Marketing Committee- the Public Relations and Marketing Committee shall be responsible for assisting in the development of concepts, logos, strategies, programs, and activities that promote the ATME College Alumni Association.
- Events Committee- the Events Committee shall be responsible for helping the Office of Institutional Advancement plan, communicate and execute events involving alumni on and off campus.
- Other Committees- the Alumni Council may create those committees required to carry out the purposes of the Alumni Association.

ARTICLE VII Amendments

Section 1: Procedure for By-Law Amendments

The By-laws may be amended at an Alumni Council Meeting or any special meeting called for that purpose, by a majority of those present at such meetings, provided that written notice of said meeting shall have been mailed to the active members at least ten (10) days prior to date of said meeting, which notice shall include the proposed amendment.

Section 2: Voting on Proposed By-Law Amendment

Adoption of the proposed amendment shall require a majority vote of the members present and voting.

ARTICLE VIII ACCOUNTS & AUDIT

- The Official year of the Association shall be from 1st April to 31st March and a Chartered Accountant shall duly audit the accounts and the remuneration shall be fixed by the members in the Annual General Body meeting. And the Accounts shall be closed 31st March every year.
- The Assets and Liabilities the Balance Sheet of the Association shall be and laid before the Annual General Body meeting for confirmation.
- Such a balance sheet and the list of Committee members shall be filed with the Registrar of Societies as per Sec. 13 of the Karnataka Societies Registration Act, 1960.

OTHER REGULATIONS

- The funds of the Association shall be invested in the modes specified under the provisions of Sec. 13 (1)(d) r.w.s. 11 (5) of the Income Tax Act, 1961 as amended from time to time.
- No amendment to the Memorandum of Association, Rules and regulations of the Association shall be made which may prove to be repugnant to the provisions of Sec.2 (15), 11, 12, 13 and 80G of the

Income Tax Act, 1961 as amended from time to time. Further no amendment shall be carried out without the prior approval of the commissioner of Income Tax.

- In the event of dissolution or winding up of the Association, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Managing committee/ Governing body but the same shall transferred to another charitable Association /Association whose objects are similar to those of this Association and which enjoys recognition u/s 80G of the Income Tax Act, 1961 as amended from time to time.
- The benefits of the Association shall be open to all irrespective of the caste creed or religion.
- The funds and the income of the Association shall be solely utilized for the achievement of the objectives and no portion of it shall be utilized for payments to the members by way of profit, interest and dividends.
- Alteration or amendment of the Memorandum of Association shall be made as per Sec.9 of the Karnataka Societies Registration Act, 1960.
- Change of Name, Rules and regulations shall be made as per Sec.10 of Karnataka Societies Registration Act, 1960.
- If the Dissolution of the Association arises, Sec.22 and 23 of Karnataka Societies Registration Act, 1960 shall be followed.
- Regarding the Amalgamation of the Association arises, Sec.21 of the Karnataka Societies Registration Act, 1960 shall be followed.
- For the matters, which have not been specified, provided to therein above, the provisions of the Karnataka Societies Registration Act, 1960 and the Rules made there under shall apply.
